28th of August, 2016 the famous historian and Africanist Natalia A. Ksenofontova celebrated a double anniversary - 75 years since she was born, and 50 years of academic activity. To date, Dr. Ksenofontova published nine personal monographs and more than one hundred chapters and articles. Many of these works were awarded prizes in the contest for the title of "Best Books of the Institute for African Studies" RAS. Her remarkable academic standing is reflected in the fact that she was the publishing editor of more than 20 personal monographs and collective publications, was elected member of the Scientific and Academic Councils of the Institute for African Studies RAS. Students and post-graduate students from different institutes and universities seek her consultation. The variety of Natalia's talents is seen not only in academic sphere, she is a talented administrator. In 1997, the Directorate of the Institute appointed her Head of the Publishing Department. In this position, she managed to organize the Institute's publishing process literally from the ground. Her

Department produces annually from 10 to 20 books, thus making an invaluable contribution to the promotion of the scientific achievements of Russian Africanists.

### **“Current state of Southern Africa. Collection of articles” has published**

Collection of articles" presents a wide spectrum of analysis by economists, historians, political scientists and culturologists from the Institute of African Studies and a number of other research and educational institutions on the problems and challenges facing the countries of the region, focusing on the most developed of them - Republic of South Africa. Such a focus on this country is counterbalanced by the articles on various aspects of politics and economics of such important countries of Southern Africa as Angola and Zambia.

The publication is consecrated to the memory of our colleague, **Gennady Vladimirovich Shubin** who abruptly left this world in early 2016 (04.09.1966-02.02.2016). As a Senior Researcher of the [Center for Southern Africa Studies](#) of the Institute for African Studies RAS and Ph.D (Hist.), he made a significant contribution to the development of African Studies in Russia.

## **The memory of the slave trade and the relationship between African-Americans and migrants from Africa in the US**

On 29th of September 2016, at the Center for European and American Studies of the Institute for Ethnology and Anthropology RAS took place the session of the seminar on foreign anthropology, devoted to the [Memory of the slave trade and the relationship between African-Americans and immigrants from Africa to the United States](#).

Dmitry M. Bondarenko, Dr.Sc. (History), Professor, Deputy Director of the Institute for African Studies RAS delivered a speech. He based his report on the materials of his fieldwork collected in the seven states of the USA during in 2013-2015. His purpose was to show how differences in historical memory of African-Americans and modern migrants from sub-Saharan Africa affect their mutual acceptance and relations.

In particular, this applies to the reflection of the transatlantic slave trade in the collective memory and mass conscience of both groups. This slave trade is a phenomenon that has contributed to the creation of the black Americans' community itself and the problem of the unity of the "black world" and its history.

The report shows that the historical memory of the transatlantic slave trade, slavery and struggle to overthrow it is the key value for the historical consciousness of the African-Americans. For African migrants to the US the topos of slavery is also important, but, firstly, not to such an extent and secondly, it is refracted in their minds at a different angle: for them it is not the story of betrayal of black people by other black people, but the story of exploitation of black people by white people.

Significant differences in perception, evaluation and attributing importance to the slave trade, slavery and struggle against it largely divide the two groups of black people in the United States, rather than unite them before the face of "white" America.

The absence of the feeling of unity of the historic past among many African-Americans and modern African migrants spiritually and mentally separates them from each other, contributing to the establishment of ambiguous and complex relationships between the two groups of black population in the US.
